

# **Affidavit Instructions**

#### **Instructions for Student:**

- 1. Complete the Affidavit of Personal Responsibility section.
- 2. Verify your state Monitor [i.e. Proctor] requirements. If your state requires a Proctor for the exam, coordinate with one PRIOR to beginning the exam.
- 3. A <u>Monitor</u> is considered a disinterested third party with no conflict of interest who verifies a student's identity and processes an affidavit testifying that the student received no outside assistance with the course or examination. This generally is administered to include individuals at least 18 years old who are neither members of the student's family nor individuals who have a financial interest in the student's success on the exam.

## **Instructions for Monitor/Proctor:**

- 1. Student must provide credentials to prove their identity (DL, Photo ID, etc.)
- 2. Exam must BEGIN and be COMPLETED in your presence.
- 3. Upon student completion of the exam, Monitor must complete and sign the Affidavit of Exam Completion and submit to us per the contact information below.

THIS FORM CAN BE COMPLETED BY PRITING OUT AND SIGNING OR ELECTRONICALLY. IF COMPLETING ELECTRONICALLY, THE BEST APPROACH IS TO HAVE THE STUDENT SIGN THE FORM THEN E-MAIL IT TO THE MONITOR FOR ELECTRONIC SIGNATURE.
